1. SACS Update

James Standley

Dr. Standley reported on the SACS office and their plans for the near future.

2. Summer/May-mester

There were some initial problems with registration for May-mester, the internal problem has now been resolved.

Dr. Brunson reported that 830 students registered for May-mester, totaling 3,000 credit hours. Online classes filled up very quickly.

It was established classes should be at least ten students or more and five for graduate courses.

3. Budget Update

An update of the budget has been sent to everyone via email. \$9 per credit hour increase in tuition has been agreed, all of which will go to faculty/staff salaries. A 3% raise pool has been approved. In addition \$500,000 has been assigned for faculty equity.

Budget sheets are due to the deans on May 9 and to the Provost on May 30, 2008.

Dr. Berry reported that the women's equestrian team has been eliminated as a sport and will go to club status.

4. Printed Class Schedule

Following a discussion about the printed class schedule at a previous meeting, it was agreed by all deans that we should keep them for now. The deans stated that the schedule provides a great deal of information, not only classes and the students like it.

5. Freshman Orientation

This will be similar to previous years, three deans are needed at each session and the following was agreed:

year to ensure they still apply and are accurate.

- c) Coordinating Board approved planning authority for Ph.D. in Psychology. We hope to start accepting students by summer/fall 2009.
