- 7. 2023-24 Budget Amendments Lysa Hagan shared the amendments made to the 2023-24 SFACS Budget, due to the increase in cost of employee insurance and cost of living increases for all employees. Upon a motion by Natalie Cardenas and a second by Judith Kruwell, the 2023-24 Budget Amendments were approved unanimously by the board.
- **8. 2024-25 Food Program Budget** Lysa Hagan shared the 2024-25 SFACS Food Program Budget. Upon a motion by Jannah Nerren and a second by Ronda McClain, the 2024-25 SFACS Food Program Budget was approved unanimously by the board.
- 9. 2024-25 SFACS Budget Lysa Hagan shared the proposed 2024-25 SFACS Budget. Dr. Judy Abbott informed the SFACS Board of an increase in the SFA School Psychology Doctoral Intern salaries. The salary for one School Psychology Doctoral Intern will increase from \$18,000 to \$30,000 for the 2024-25 school year. Upon a motion by Jannah Nerren and a second by Judith Kruwell, the 2024-25 SFACS Budget was approved with an amendment of a change of \$12,000 increase for SFACS School Psychology Doctoral Interns.
