# For incidents occurring between January 01, 2022 and January 01, 2025

# Case 2: Sigma Tau Gamma

# **Description of Incident:**

It was reported new members were being required to kiss each other.

# Alleged Violation(s) of the Student Code of Conduct:

• Article V, Section I: Hazing

# **Findings of Case:**

The evidence and report submitted originated from 3 calendar years prior. In addition, both parties pictured were current members not acting in any capacity affiliated with the chapter, therefore charges against Sigma Tau Gamma were dismissed.

# Case 3: Pi Kappa Alpha

Pi Kappa Alpha

#### **Date of Incident:**

September 14, 2024

# **Date Investigation Initiated:**

September 16, 2024

#### **Description of Incident:**

It was reported there an unresponsive male that was seizing due to alcohol consumption, that was being transported from the Pi Kappa Alpha House.

#### **Alleged Violation(s) of the Student Code of Conduct:**

• Article V, Section I: Hazing

• Article V, Section A: Alcohol – Furnishing

• Article V, Section M: Joint Responsibility

#### **Findings of Case:**

There was sufficient evidence to support a finding of responsibility, mainly to the student in question being transported by ambulance to the hospital due to alcohol consumption and the student was underage, brought their own alcohol, and the organization facilitating the consumption by hosting the gathering and not monitoring who was drinking. There was no evidence to support the hazing charge, thus the finding of not responsible.

#### Sanctions:

- Placed on Behavioral Conduct Probation effective September 26, 2024 through September 26, 2026
- Risk Management Education Facilitated by the Pi Kappa Alpha National Office, educate all men in the organization on PIKE and NIC risk management standards, particularly in reference to hosting events. Must have at least 90% of brother in attendance. Submit proof of completion to DSO. Due date January 01, 2025.
- Host educational event where law enforcement and first responders attend to educate on host liability laws, impact of alcohol, etc. 90% of brothers must be in attendance. Due date January 01, 2025.
- Complete any and all sanctions assigned by PIKE national office

It was reported members of the organization exposed their genitalia while another chapter member was sleeping. Additionally, it was reported that members were being forced to perform fellatio on other members, among other activities that would constitute hazing.

#### **Alleged Violation(s) of the Student Code of Conduct:**

• Article V, Section I: Hazing

#### **Findings of Case:**

University found there to be no evidence the activities in question were formal or informal chapter activities. While the photo and activity may have been in poor taste, there was not a preponderance to warrant a finding of responsibility for the hazing charge. It should also be noted that all individuals in the picture willingly engaged, so there are no violations of any other university policies, therefore Theta Chi was found not responsible.

It was reported members are being required to stay extra time, potentially not eating, undergoing verbal abuse, and required to pay monies for recruitment.

# **Alleged Violation(s) of the Student Code of Conduct:**

• Article V, Section I: Hazing

#### **Findings of Case:**

\$50 dollars was requested for food and snacks as the org was preparing for recruitment during work week. Chapter furnished several announcements about the use of those funds. Additionally, Breakfast, Lunch, and Dinner was provided to all members regardless if they were able to pitch in or not, therefore charges against Chi Omega were dismissed.

- Article V, Section M.ii: Joint Responsibility Others Action
- Article V, Section A.vi: Alcohol Common Source

There was not enough substantial information to support any findings of responsibility, therefore charges against Theta Chi were dismissed.

• Article V, Section I: Hazing

#### **Findings of Case:**

There was not enough substantial information to support any hazing allegation, therefore charges against Sigma Tau Gamma – Gamma Pi Chapter was dismissed.

• Article III, Section 2c: Article V, Section I: Hazing

# **Findings of Case:**

There was not enough substantial information to support any hazing allegation, therefore charges against Sigma Chi – Eta Tau Chapter was dismissed.

The Alpha Tau Omega – Eta Iota Chapter was found not responsible for violating Article V, Section I: Hazing and Article V, Section Q: Retaliation.

There was not enough substantial information to support any hazing allegation, therefore charges against Kappa Sigma – Nu Tau Chapter was dismissed.

# Alleged Violation(s) of the Student Code of Conduct:

• Article V, Section I: Hazing

# **Findings of Case:**

There was not enough substantial information to support any hazing allegation, therefore charges against Theta Chi – Epsilon Tau Chapter was dismissed.

#### Case 16: Delta Tau Delta

# **Description of Incident:**

It was reported on September 20th, that the members of Delta Tau Delta were at the Frogs sports bar with their new members present. It was also reported that several of their new members have been seen sleeping outside of, and have checked in every morning at the Campus Rec Center around 6:00 AM.

#### **Alleged Violation(s) of the Student Code of Conduct:**

- Article V, Section I: Hazing
- Article V, Section A.i: Alcohol Use/Possession Under 21
- Article V, Section K.ii: Harm Endangerment
- Article V, Section O.ii: Obstruction of Student Conduct Process False Information
- Article V, Section M.ii: Joint Responsibility Others Action

#### **Findings of Case:**

The Delta Tau Delta – Zeta Psi Chapter was found responsible for violating Article V, Section I: Hazing,, Article V, Section K.ii: Harm – Endangerment, Article V, Section O.ii: Obstruction of Student Conduct Process - False Information. Additionally, the Delta Tau Delta – Zeta Psi Chapter was found not responsible for violating, Article V, Section A.i: Alcohol - Use/Possession Under 21, Article V, Section M.ii: Joint Responsibility - Others Action.

#### **Sanctions:**

- Suspension: The Delta Tau Delta Zeta Psi Chapter is suspended effective November 15, 2023 through November 15, 2026.
- Placed on Behavioral Conduct Probation, effecting November 16, 2026 and ending November 16, 2031.
- Membership review of any currently active members that may still be a registered student once the term of the suspension has expired.
- Completion of any and all sanctions assigned by the Delta Tau Delta national office.

# Case 17: Alpha Phi Omega

#### **Date Investigation Initiated:**

March 1, 2023

#### **Description of Incident:**

Fraternity members allegedly required pledges to participate in scavenger hunts, "call outs", and reciting information upon command. Additionally, pledges were deserted into the woods, forced to perform physical activities, and forced to consume alcohol.

# Alleged Violation(s) of the Student Code of Conduct:

- Article III, Section 2c: Hazing Sleep Deprivation, Exposure, Confinement, Calisthenics, or Similar
- Article III, Section 2h: Hazing Intentionally, Recklessly, or Knowingly Permitting Hazing to Occur
- Article III, Section 1b: Harm to Others Endangerment
- Article III, Section 5d: Disorderly Conduct Facilitation of Student Misconduct

#### **Findings of Case:**

The Alpha Phi Omega – Nu Sigma Chapter was found responsible for violating Article III, Section 2c: Hazing – Sleep Deprivation, Exposure, Confinement, Calisthenics, or Similar and Article III, Section 2h: Hazing – Intentionally, Recklessly, or Knowingly Permitting Hazing to Occur. Additionally, the Alpha Phi Omega – Nu Sigma chapter was found not responsible for violating Article III, Section 1b: Harm to Others – Endangerment and Article III, Section 5d: Disorderly Conduct – Facilitation of Student Misconduct.

#### **Sanctions:**

- Suspension: The SFA Nu Sigma chapter of Alpha Phi Omega is suspended effective April 13, 2023 through April 14, 2025.
- Membership review of any currently active members that may still be a registered student once the term of the suspension has expired.
- National representatives must meet with the Office of Student Engagement to develop a strategic plan for future success of the organization.

- Article III, Section 2d: Hazing Consumption of Food, Drug, Alcohol, or other Substance
- Article III, Section 8b: Prohibited Possession or Use of Alcohol Distribution

# **Findings of Case:**

All charges dismissed as the event occurred off-campus and did not meet the standard of adversely affecting the University community and/or the pursuit of its objectives (from the Student Code of Conduct, Article II: Jurisdiction).
