Monday October 30, 2023 – Tuesday October 31, 2023

There are no reports.

Friday October 27, 2023 – Monday October 30, 2023

On 10-27-2023, UPD officers responded to Steen Hall to meet with a complainant in reference to a theft. The complainant advised on 10-27-2023 they placed an order through Door Dash. The complainant advised that the Door Dash driver delivered their food to the building but took the food back with them and left the scene before the complainant picked up the order. There is one suspect.

Wednesday October 25, 2023 – Friday October 27, 2023

On 10-25-2023, UPD officers responded to Hall 10 in reference to a criminal mischief. Officers learned that someone had thrown a rock through a window in Hall 10. There are no suspects.

Tuesday October 24, 2023 – Wednesday October 25, 2023

On 10/24/2023 an officer was dispatched to the lobby of UPD in reference to theft. The complainant advised between 10-21-2023 and 10-23-2023, her secured bicycle was stolen from the area of the Human Sciences south building. There are no suspects.

On 10-23-2023 an officer was dispatched to Kerr Hall in reference to hit and run. The complainant advised on 10/23/2023, her vehicle was damaged in the Lumberjack Village parking garage. There are no suspects.

Friday October 20, 2023 – Monday October 23, 2023

On 10-20-2023 an officer was dispatched to the lobby of UPD to speak with a complainant in reference to theft. The complainant advised on 10-18-2023 he lost his wallet at the SFA Recreation Center. He stated on 10-20-2023 his wallet was

located by staff near the pool area and money had been stolen from the wallet. There are no suspects.

Tuesday October 17, 2023 – Wednesday October 18, 2023

On 10-18-2023, UPD officers responded to the Stephen F. Austin statue and fountain in reference to a criminal mischief. Officers determined that the suspect(s) had poured liquid detergent into the fountain and fled the area. There are multiple suspects.

Monday October 16, 2023 – Tuesday October 17, 2023

On 10-16-2023, UPD Officers met with a complainant at UPD in reference to a sexual assault. The complainant advised on 10-14-2023 they were sexually assaulted by a known subject in Hall 14. This incident is under investigation. There is one suspect.

On 10-16-2023, UPD officers met with a complainant at Hall 20 in reference to a hit and run. The complainant advised that sometime in the last two weeks their vehicle was damaged while parked in Lot 46. There are no suspects.

On 10-16-2023, UPD officers met with a complainant at UPD in reference to a hit and run. The complainant advised that on 10-14-2023 their vehicle was damaged while parked in the 700 block of Mound Street. There are no suspects.

Friday October 13, 2023 – Monday October 16, 2023

On 10-14-2023, UPD officers responded to Hall 14 in reference to a theft. The complainant advised on 10-14-2023 some of her clothing was taken from the laundry room in Hall 14. There are no suspects.

On 10-14-2023, UPD officers responded to the Stadium in reference to a theft. The complainant advised that several chair backings were removed from the reserve section of the stadium. There are no suspects.

Thursday October 12, 2023 – Friday October 13, 2023

On 10-12-2023, UPD officers responded to Lot 29 in reference to a hit and run. Officers spoke to a witness that provided the officer with a license plate number. The vehicle and driver were located a short time later. The driver was arrested for failure to report striking an unattended vehicle. The driver was transported to the Nacogdoches County Jail without incident.

On 10-12-2023, UPD officers responded to Lot 43 in reference to a hit and run. The complainant advised that between 10-11-2023 and 10-12-2023 their vehicle was damaged while parked in Lot 43. There are no suspects.

On 10-12-2023, UPD officers responded to the Human Services Building to meet with a complainant in reference to an assault. The complaint advised that on 9-27-2023 someone walked up behind them and grabbed their neck. The complainant advised they were walking on the sidewalk along North street between Alumni and Griffith Hall when this took place. This incident is under investigation. There are no suspects.

On 10-12-2023, UPD officers responded to the Vista Drive bus stop to meet with a complainant in reference to a Terroristic Threat. The complainant advised as they walked by the bus stop an unidentified female pointed what she believed to be a weapon at her. Officers were provided with a description of the female but were unable to locate anyone. There are no suspects.

Monday October 9, 2023 – Tuesday October 10, 2023

On 10-9-2023, UPD officers responded to the Lumberjack Village Parking Garage in reference to two individuals with BB guns. At that time officers were unable to locate the individuals but were advised by a complainant that an exterior glass door to Lumberjack Village #3 had been damaged by a BB. UPD officers were able to identify two individuals through security cameras responsible for the damaged door. This incident is currently under investigation.

On 10-8-2023, UPD officers responded to Lot 51 in reference to a burglary of a motor vehicle. The complainant advised that on 10-8-2023, someone broke out her driver's side window and removed property from inside of their vehicle. There are no suspects.

Thursday October 5, 2023 – Monday October 9, 2023

On 10-6-2023, UPD officers contacted two subjects in the Children's Garden of the Arboretum. The officers could smell burnt marijuana and questioned the two subjects if they had any marijuana in their possession. One subject was found to be in possession of marijuana. That subject was issued a class-b summons for possession of marijuana. There is one suspect.

On 10-8-2023, UPD officers were dispatched to five different incidents of criminal mischief involving vehicle windows being damaged by pellet guns. All five of the incidents took place on 10-8-2023 in Lots 42 and 43. These incidents are under investigation and officers are aware of multiple suspects.

On 10-8-2023, UPD officers responded to Lot 51 in reference to a burglary of a motor vehicle. The complainant advised on 10-8-2023 someone broke out her vehicle window and removed her property from inside of her vehicle. There are no suspects.

On 10-9-2023, a UPD officer observed a subject in a vehicle parked in Lot 43 that was revving their engine. The officer walked over to the vehicle and observed the occupant to be drinking from a beer can. The driver was identified and found to be under 21 years of age. The occupant was issued a citation for minor in possession of alcohol. There is one suspect.

Wednesday October 4, 2023 – Thursday October 5, 2023

Tuesday October 3, 2023 – Wednesday October 4, 2023

On 10-3-2023, UPD officers responded to Lumberjack Village in reference to theft of a bicycle. The complainant advised that between 10-2-2023 and 10-3-2023 their secured bicycle was removed from the bike rack located by Village #1. There are no suspects.

On 10-3-2023, UPD officers responded to the police department to meet with a complainant in reference to criminal mischief. The complainant advised that on

10-3-2023 their vehicle's passenger side window was damaged while parked in Lot 52. There are no suspects.

On 10-4-2023, UPD officers contacted a suspicious vehicle in Lot 3. As officers approached the vehicle they could smell an odor of marihuana coming from inside the vehicle. When officers questioned the driver, they admitted to smoking marihuana and using THC Wax. A probable cause search of the vehicle was conducted and officers located a jar of THC Wax and a firearm. The driver was arrested for unlawful carrying of a weapon and possession of a controlled substance. The driver was then transported to the Nacogdoches County Jail without incident.

Monday October 2, 2023 – Tuesday October 3, 2023

On 10-2-2023, UPD officers responded to Hall 14 in reference to a noise complaint and possible alcohol offense. Upon arrival officers could hear loud music and people yelling profanities from inside a residence. Officers contacted four subjects inside the residence and also found one bottle of alcohol. One subject claimed ownership of the alcohol and was found to be under 21 years of age. That subject was issued a citation for minor in possession of alcohol.

Friday September 29, 2023 – Monday October 2, 2023

On 10-1-2023, UPD officers assisted Nacogdoches Police Department officers at the River Park Apartments located at 315 Ellington Street in reference to a stolen golf cart. UPD officers recovered two golf carts from the apartment complex that belonged to SFA. UPD officers were able to determine that on 10-1-2023 five suspects took the carts from SFA property without consent. This incident is currently under investigation.

On 9-30-2023, UPD officers responded to Kerr Hall in reference to an unresponsive person in the hallway. Officers arrived and contacted a student who was intoxicated to the point of being in danger to themselves and others. Officers placed the subject under arrest for public intoxication and transported the subject to the Nacogdoches County Jail without incident.
