The driver was arrested for possession of marihuana and transported to the Nacogdoches County Jail without incident.

On 4-14-2024, UPD officers were called to assist Nacogdoches Police Department with a large disturbance in the 1500 block of North Street. While officers were on scene a UPD officer observed one subject who appeared agitated. The officer then saw the grip of a firearm hanging out from the subject's pants. The subject was confronted by officers and taken into custody. A search of the subject's person revealed the subject to be in possession of a handgun and marihuana. The subject was arrested for unlawful carrying of a weapon and possession of marihuana. He was then transported to the Nacogdoches County Jail without incident.
